News:

Bramer Bank – following the communique issued by the Bank of Mauritius (BOM) on 02 April 2015, on the revocation of the banking licence of BBCL, dealing in BBCL shares was suspended by SEM today until further notice. According to BOM's communique "BBCL has been experiencing large withdrawals of deposits placing it in a precarious liquidity situation. That was further worsened by its difficulty to raise funds on the interbank market. It has relied heavily and continuously on a daily basis since 6 March 2015 for overnight facility from the Bank. It has also failed to maintain the minimum cash reserve requirement as from the maintenance period that started 5 March 2015".

Bluelife: currently the company is conducting a major review of the operations of its two hotels and major announcements namely appointment of new CEO, appointment of an internationally renowned Hotel operator for management of two hotels and restructure of existing financing facilities shall be communicated in coming weeks.

Lux: has announced the disposal of its shareholding in Les Villas du Récif which owns and operates Le Récif hotel in Réunion Island to Asian Prosperous Holding Ltd. Lux's debt will be reduced by Rs200m. Moreover, two long term management services contracts has been signed namely with the new owner of hotel Le Récif and Reunion based 5 star luxury resort SAS Le Superbe (owned by Asian Prosperous Holding Ltd).

Delta: SEM has approved the placing, issue and listing of up to 29m additional ordinary shares of the company on the official market by way of private placement at the USD price equivalent of ZAR 18 per share which was based on opening price of USD 1.65 on its first trading day on 30 March 2015 and discounted by approximately 9%.

Official Market

Both *indices* ended on a negative note with the *Semdex* and *SEM-10* losing 0.6% and 0.9% to finish at 1,972.98 points and 374.31 points respectively. Market activities was high over the week, except for Friday's session, which resulted to an *overall turnover of* Rs678.3m (USD 18.7m), driven mainly by *MCBG* which accounted for 61%. Yet again, *foreign investors* were net sellers to the tune of R368.6m.

Significant volume of 2.1m shares were traded on *MCBG* and foreign investors were net sellers of amount Rs310.8m on the stock. The latter traded on a weekly VWAP of Rs197.14 but ended the week at Rs197.50, losing 0.5% on a w-o-w basis. *SBMH* also lost 2.0% to end at Rs0.96 on total volume of 19.6m shares exchanged. Prior to its suspension of dealings, *Bramer Bank* traded in the range Rs3.70 to Rs4.30 with overall volume of 316.4k shares exchanged. *CFS* dropped further by 2.2% to Rs8.78 on 221.2k shares traded. On the *insurance* counter, only mover was *MUA* which fell by 2.3% to Rs75.00 on 5.2k shares.

On the $\it commerce$ counter, $\it ENL$ $\it Commercial$ and $\it IBL$ decreased by 1.1% and 0.9% to Rs22.00 and 115.00 on 11.1k shares and 2.8k shares respectively.

At the level of *industrials*, sole mover was *UBP* which saw several crosses during the week resulting to 201.5k shares traded and the stock ended lower at Rs86.50 (-2.8% w-o-w). *PBL* remained flat at Rs280.00 on 58.2k shares exchanged, mainly on foreign buy.

Notable volume of 2.8m was traded on *CIEL* which ended the week higher at Rs6.90 (+0.9%). *P.O.L.I.C.Y* (Unch.) and *Rogers* (+1.9%) also saw significant trades of 649.4k shares and 627.8k shares. *Alteo* grew by 1.4% to Rs33.00 on 55.7k shares exchanged whilst *Terra* shed off 2.3% to Rs32.50 on 30.0k shares. *United Docks* climbed by 4.8% to Rs65.00 on only 100 shares. Other losers across the investment were *Fincorp* (-2.7%), *ENL Land (O)* (-1.0%), *Caudan* (-0.8%), *MDIT* (-0.7%).

Lottotech recouped its week low of Rs5.00 to finish today's session at Rs6.40, however experiencing a loss of 1.2% on total volume of 516.6k shares traded. Mixed feelings were noted on the hotel counter. **NMH** saw notable volume of 1.8m shares traded on a weekly VWAP of Rs66.92 but ended at Rs64.00 (-4.5%) with net foreign sales of Rs95.5m. **LUX**, edged down by 0.8% to Rs59.50 on 304.9k shares, whilst **SUN** was the top performer for the week rallying 5.6% to Rs39.60 on 72.3k shares exchanged. **Air Mauritius** tumbled by 8.1% to Rs13.10 on 35.8k shares.

Blue life shed off its week high of Rs6.10 to close at Rs5.68 (-2.1%), whilst Omnicane rose by 2.6% to Rs78.00 on 9.9k shares.

DEM Market

The **Demex** gained 1.2% to 204.92 points. **Weekly turnover** amounted to Rs44.8m, geared towards **Hotelest**, **Medine** and **Constance Hotels Services**. Both **Hotelest** and **Constance** increased by 2.7% to Rs38.00 on 357.1k shares and 110.4k shares respectively. **Medine** grew by 2.0% to Rs65.25 on 116.9k shares traded. **Anglo Mauritius Assurance** grew by 2.4% to Rs850.00 on 9.9k shares exchanged. Main gainer was **Ascencia Class A** which climbed by 9.2% to Rs13.10 on 11.5k shares. Other movers were **ENL Ltd (P)** (-4.4%), **Bychemex** (-2.8%), **Ciel Textile** (+0.7%) and **ENL Investment** (-0.5%).


