Further to the Cautionary Announcement and the Notice issued on 17 December 2015, regarding the proposed amalgamation of ENL Investment Limited ('ENL Investment') with and into ENL Land Ltd ('ENL Land') under sections 245 and 246 of the Companies Act 2001 (the 'Amalgamation'), the Board of Directors of ENL Land is pleased to inform its shareholders and the public in general of the following:

At a special meeting of ENL Land held on 15 January 2016, the shareholders have:

- adopted a new constitution for ENL Land;
- approved the amalgamation of ENL Land with ENL Investment in accordance with and pursuant to the provisions of the Companies Act 2001 on terms and conditions as set out in the Amalgamation Proposal dated 17 December 2015.

The Amalgamation has also been approved by the shareholders of ENL Investment at a special meeting held on 15 January 2016.

Subject to the approval of the Registrar of Companies, ENL Land will therefore remain as the amalgamated company with effect 1st February 2016 (the 'Effective Date').

The shares of ENL Investment will be cancelled and ENL Land will issue to the shareholders of ENL Investment 1.057 new ENL Land shares for every 1 ENL Investment share.
